## Notice of Initiation Anti-dumping Investigation against Alleged Dumping of Polyvinyl Chloride into Pakistan Originating in and/or Exported from the Chinese Taipei (Taiwan), And Republic of Korea.

National Tariff Commission (Commission) has received an application under Section 20 of Anti-Dumping Duties Ordinance, 2000 (Ordinance) on September 20, 2013 from Engro Polymers and Chemicals Limited., 16th Floor, The Harbour Front Building, HC-3, Marine Drive, Block 4, Clifton, Karachi-75600 (Applican). The Applicant is a producer of Polyvinyl Chloride (PVC). The Applicant has alleged that PVC is being exported to Pakistan at dumped prices from the Republic of China ("Taiwan"), and Republic of Korea ("Korea") (hereinafter referred to collectively as the "Exporting Countries"). It is further alleged that the imports of PVC from the Exporting Countries has caused and is causing material injury to the domestic industry.

**Initiation of Investigation:** The Commission hereby initiates an investigation pursuant to Section 23 of the Ordinance. The investigation will determine whether PVC originating in and/or exported from the Exporting Countries is being dumped into Pakistan and whether such dumping has caused and/or is causing material injury to the domestic industry. The Commission will, during the course of this investigation, call for any further information/ data deemed necessary for the purposes of this investigation.

**Product under Investigation:** The investigated product is Polyvinyl Chloride imported into Pakistan from the Exporting Countries. It is classified under PCT Heading No. 3904.1090. Investigated product is mainly used in manufacturing of Pipes & Fittings, Garden Hose, Shoes, Cable, Films & Sheets, Compounding, Packaging, etc.

## **Period of Investigation ("POI"):**

For determination of dumping: From October 1, 2012 to September 30, 2013 From October 1, 2010 to September 30, 2013

## **Investigation Schedule:**

**Date of initiation of investigation:** The date of publication of this notice in the newspapers in Pakistan.

Not earlier than 60 days and not later than 180 days from the date

of initiation of the investigation.

**Date of final determination:** Will be notified in notice of preliminary determination.
