<u>Investigated Product</u>	Glacial Acetic Acid (the "investigated product") is classified under Pakistan Customs Tariff ("PCT") Code 2915.2100. Major uses of investigated product are in the manufacture of; cellulose acetate fibre, pure terephthalic acid (PTA), ester solvents, dyes and metal salts, textile processing, pharmaceuticals etc. However GAA accounts

<u>Application</u> The Applicant lodged the application on July 4, 2003 alleging dumping of the investigated product into Pakistan by Chang Chun Petrochemical Company Limited, 301 Songkiang Road, 7<sup>th</sup> Floor, Taipei-104, Taiwan, a producer and exporter from Taiwan. The Applicant represents 100 percent of the domestic production of the like product. The Applicant, therefore, constitutes the domestic industry.

for a minor share in cost of production of these industries.

### **Allegation of Dumping**

The Applicant has alleged that investigated product is being exported to Pakistan from Taiwan at prices less than the normal value of the product.

## Alle gation of Injury

The Applicant has alleged that dumped imports of investigated product from Taiwan has caused and is causing material injury to the domestic industry, mainly, by way of; price under-cutting, price depression, price suppression, loss in market share, loss in capacity utilization, inventory build ups of domestic like product, negative cash flows on its operations etc. Resultantly the domestic industry has incurred losses on its operations.

# **Initiation of Investigation**

The Commission hereby initiates the investigation pursuant to Section 23 of the Ordinance. The investigation will determine whether the investigated product originating in and exported from Taiwan is being dumped into Pakistan and whether such dumping has caused and/or is causing material injury to the domestic industry.

## **Collection of Information**

In order to obtain data/information deemed necessary for the investigation, the Commission in terms of Rule 8 of the Antidumping Rules, 2001 (hereinafter referred to as the "Rules") will send questionnaires to all known exporters, foreign producers and importers of the investigated product. The Commission may also, during the course of this investigation, request for any further information/data deemed necessary for the purposes of this investigation.
