Notice of Initiation of Newcomer Review of Definitive Antidumping Duties Imposed on <u>Dumped Imports of Tiles Originating in and/or Exported from the People's Republic of China</u>

The National Tariff Commission (the "Commission") received two application under Section 60 of Anti-Dumping Duties Ordinance, 2000 (the "Ordinance") on September 05, 2008 and September 09, 2008 from M/s Tangshan Huida Ceramic Group Co., Ltd., Huida Ceramics City, Tangshan City, Hebei, China, and Fujian International Trade Development Company, Ltd. 21F, World Trade Plaza No.71, Wusi Avenue, Fuzhou, China (the "Applicants"), exporters of Ceramic Tiles, requesting the Commission to determine individual dumping margin for their exports of tiles to Pakistan.

Existing Anti-dumping Duty

Earlier, upon request of the domestic industry, the Commission had conducted an anti-dumping investigation on dumped imports of tiles originating in and/or exported from People's Republic of China ("China") in the year 2006 (A.D.C No.11/2006/NTC/CT). The Commission made an affirmative final determination of dumping of tiles and material injury to the domestic industry on March 30, 2007 and imposed definitive anti-dumping duties on dumped imports of tiles originated in and/or exported from China, ranging from 14.85 percent to 23.65 percent. The Applicants are liable to pay 23.65 percent anti-dumping duty on their exports of tiles to Pakistan.

Grounds for Newcomer Review under Section 60 of the Ordinance

The Applicants have stated that: (i) they did not export tiles to Pakistan during the period of investigation (from January 1, 2005 to December 31, 2005), on basis of which the anti-dumping duty was imposed; (ii) not related to any exporter or producer who are subject to anti-dumping duty; and (iii) they exported tiles into Pakistan after imposition of anti-dumping duty on the investigated product.

Product under Review

The product under review is ceramic tiles (excluding porcelain/vitrified/granite) of a size 200x300 mm, 250x330 mm and border of size 80x330 mm., exported by the Applicants and produced by Tangshan Huida Ceramic Group Huiqun Co., Ltd., Huida Ceramic City, Tangshan, Hebei, China and Fujian Minqing Gangcheng Ceramic Tile Company, Ltd. Dianqian Village, Minqing Town, Fuzhou, China. The product under review is classified under Pakistan Customs Tariff ("PCT") Heading Nos. 6908.9010.

Initiation of Newcomer Review

Upon examination of the applications, the Commission hereby initiates a review pursuant to Section 60(2) of the Ordinance to determine that:

- (i) the Applicants have not exported product under review to Pakistan during the original POI;
- (ii) the Applicants are not related to any of the exporters or producers who are subject to the anti-dumping duty imposed by the Commission following the original investigation;
- (iii) the Applicant have exported product under review to Pakistan in commercial quantities after imposition of definitive anti-dumping duty on tiles originating in and/or exported from China to Pakistan; and
- (iv) individual dumping margin for the Applicants.

Period of Review ("POR")

POR for determination of individual dumping margin for the Applicants is from April 1, 2007 to March 31, 2008

Investigation Schedule

Date of initiation of Review: The date of publication of this notice in the press in Pakistan

Date of Completion of the Review: Within six months of the date of publication of notice of initiation of

review, but in any event not later than twelve months in accordance with

Section 60(1) of the Ordinance

Requirement of Security Cash Deposit

The Applicants shall make a cash deposit in the amount equal to the residual anti-dumping duty rate of 23.65% ad val, determined pursuant to sub-section (5) of section 51 of the Ordinance on their exports to Pakistan to ensure that, should the determination of review results in an affirmative dumping margin with respect to the Applicants, anti-dumping duty can be levied retroactively from the date of initiation of the review. The reason for collection of such cash deposit is that during the review no anti-dumping measures shall be imposed on

imports from the Applicants pursuant to Section 60(3) of the Ordinance. The cash deposit would be collected in the same manner as definitive anti-dumping duty being collected by the Federal Board of Revenue in accordance of the Commission's notification dated March 30, 2007 and will be deposited in the Commission's Non-lapsable PLD Account No. 187 with Federal Treasury Office, Islamabad.

An interested party applying for registration with the Commission in this review should submit; the name of the company, its line of business, name of authorized person, address, telephone number and fax number.

All interested parties are invited to make their views/comments known to the Commission, and to submit information and documents (if any) not later than 30 days of the date of publication of this notice in the press in Pakistan. All data and information in this regard should be submitted to the Secretary of the Commission.

Hearing

Any interested party may, if it so wishes, request a hearing in accordance with Rule 14 of the Anti-Dumping Duties Rules 2001 (the "Rules") within 45 days of the publication of this notice by contacting Secretary of the Commission.

Use of Best Information Available

Where any interested party refuses or otherwise does not provide the required information within the prescribed time limit or significantly impedes the review, conclusion of the review by the Commission will be made on the basis of best information available in accordance with Section 32 of the Ordinance and the Schedule appended the Ordinance.

Public File

In accordance with Rule 7 of the Anti-Dumping Duties Rules, 2001, the Commission has established and maintained a public file at its offices, which shall be available to the interested parties for review and copying from Monday to Thursday (except public holidays) between 1100 hours to 1300 hours throughout the review.
