

**Notice of Conclusion of Newcomer Review of Definitive Antidumping Duties Imposed on Dumped Imports of Polyester Filament Yarn Originating in and/or Exported from the Republic of Korea**

The National Tariff Commission (the "Commission") initiated a newcomer review on September 27, 2010 after establishing that the application lodged by M/S TK Chemical Corporation, 14<sup>th</sup> Floor Singsong Centre Building, 25-12 Yoido-dong, Youngdungpo, Seoul, South Korea (the "Applicant") was prima facie in accordance with requirements of Section 60 of the Anti-Dumping Duties Ordinance, 2000 (the "Ordinance"). The newcomer review was relating to definitive antidumping duties imposed on dumped imports of Polyester Filament Yarn ("PFY") originating in and/or exported from the Republic of Korea. In accordance with provisions of the Ordinance and the Anti-Dumping Duties Rules, 2001 (the "Rules"), the Commission has determined following in this review:

**Antidumping Duties in force:** the Commission conducted an antidumping investigation on imports of PFY originating in and/or exported from Indonesia, Korea, Malaysia and Thailand (the "Exporting Countries") in the year 2005 and imposed antidumping duties on dumped imports of PFY originated in and/or exported from the Exporting Countries ranging from zero percent to 29.68 percent for a period of five years effective from November 12, 2005. The Applicant was liable to pay 6.92 percent *ad valorem* as antidumping duty on its exports of PFY to Pakistan.

**Product under Review:** The product under review is PFY produced and exported by the Applicant. The product under review is mainly used in the manufacturing of art silk fabrics and garments. It is classified under Pakistan Customs Tariff Heading Nos. 5402.3300 and 5402.4700.

**Period of Review ("POR"):** POR for determination of individual dumping margin for the Applicant was from July 1, 2009 to June 30, 2010.

**Imports of the Product Under Review:** The Commission's investigation has revealed that the Applicant did not export product under review during original period of investigation. The Commission has also determined that the Applicant exported product under review on regular basis in commercial quantities during POR.

**Relationship of the Applicant with Other Exporters or Producers:** After investigation, the Commission has determined that the Applicant is not related to any of the exporter and producer who is subject to definitive antidumping duties imposed on PFY.

**Individual Dumping Margin for the Applicants:** The Commission has determined individual dumping margin for the Applicants, which works out to -0.78 percent i.e. *de minimis*.

**Antidumping Duty Applicable to Applicant:** As individual dumping margin for the Applicant is at *de minimis* level, no antidumping duty is imposed on its exports of the product under review with effect from September 27, 2010 under Section 60(3) of the Ordinance.
