**Notice of Initiation of Anti-Dumping Investigation on Alleged Dumped Imports of Vinyl/ PVC Flooring Originating in and/or Exported from the People's Republic of China into Pakistan**

National Tariff Commission (the "Commission") has received an application on April 01, 2022 under Section 20 of Anti-Dumping Duties Act, 2015 (the "Act") from M/s Asia Vinyl and Rubber Industries, Lahore (the "Applicant"). The Applicant is a producer of Vinyl/ PVC Flooring ("PVC Flooring"). The Applicant has alleged that PVC flooring is being exported to Pakistan at dumped prices from the People's Republic of China ("China"), which has caused and is causing injury to the domestic industry producing domestic like product.

Upon initial examination and assessing accuracy and adequacy of the evidence and information provided in application in accordance with Section 23 of the Act, the Commission is satisfied that the evidence and information provided in the application is sufficient to justify initiation of an investigation into the matter.

**Initiation of Investigation:** The Commission hereby initiates an investigation pursuant to Section 23 of the Act. The investigation will determine whether PVC flooring originating in and/or exported from China is dumped into Pakistan and whether such dumping has caused and /or threaten to cause injury to the domestic industry within the meaning of provisions of the Act. The Commission, during course of this investigation, will call further information/data from the interested parties deemed necessary for the purposes of this Investigation.

**Product under Investigation:** The product allegedly being dumped into Pakistan is Vinyl/ PVC flooring, cut to length in form of Planks and Tiles of a thickness ranging from 1 mm to 5 mm (the "investigated product"). The investigated product is classified under Pakistan Customs Tariff ("PCT") Heading No 3918.1000. The Investigated product is used as flooring in residential, commercial, healthcare, offices etc.

**Period of Investigation (POI):** For determination of dumping and injury, the POI is as follows:

For determination of dumping:	From January 01, 2021, to December 31, 2021
For determination of injury:	From January 01, 2019, to December 31, 2021

All interested parties are invited to make their views/comments known to the Commission and to submit information and documents (if any) not later than 45 days of the date of publication of this notice in the press in Pakistan. All written submissions provided by interested parties on a confidential basis must be marked "Confidential" and in accordance with Section 31 of the Act, shall be accompanied by a non-confidential version/summary which will be placed in the public file. Date of initiation of investigation:	The date of publication of this notice in the press in Pakistan.
Date of preliminary determination:	Not earlier than 60 days and not later than 180 days from the date of initiation of the investigation.
Date of final determination:	Within 180 days of the date of publication of notice of preliminary determination in the press in Pakistan

**Public File:** In accordance with Rule 7 of the Anti-Dumping Duties Rules 2001, the Commission has established and shall maintain a public file at its office, which shall be available to interested parties for review and copying from Monday to Thursday between 1100 hours to 1300 hours (except public holidays) throughout the review.
