**Notice of Initiation of Anti-Dumping Investigation Against Alleged Dumped Imports of Polyester Filament Yarn into Pakistan Originating in and/or Exported from the People's Republic of China**

National Tariff Commission (the "Commission") has received an application under Section 20 of the Anti-Dumping Duties Act, 2015, (the "Act") on March 29, 2024, from M/s. Gatron Industries Limited, and M/s. Rupali Polyester Limited (the "Applicants"), who are producers of Polyester Filament Yarn ("PFY"). The Applicants have alleged that PFY is being exported to Pakistan at dumped prices from China. According to the Applicants, the alleged dumped imports of PFY from China have caused and are causing material injury to the domestic industry producing PFY.

Upon initial examination and scrutiny of the information and evidence provided in the application in accordance with Section 23 of the Act, the Commission is satisfied that the information and evidence provided in the application is sufficient to justify initiation of this investigation.

**Initiation of Investigation:** The Commission hereby initiates an anti-dumping investigation pursuant to Section 23 of the Act. The investigation will determine whether PFY originating in and/or exported from China is dumped into Pakistan and whether such dumping has caused and /or is causing injury to the domestic industry within the meaning of provisions of the Act. The Commission, during the course of this investigation, will seek further information/data from the interested parties deemed necessary for the purposes of this investigation.

**Product under Investigation:** The product allegedly being dumped into Pakistan is Polyester Filament Yarn ("PFY") (the "investigated product"), excluding Fully Drawn Yarn. The investigated product is classified under Pakistan Customs Tariff ("PCT") Heading Nos. 5402.3300 and 5402.6200.

**Period of Investigation (POI):** For determination of dumping and injury, the POI is as follows:

For determination of dumping:	From January 01, 2023 to December 31, 2023
For determination of injury:	From January 01, 2021 to December 31, 2023

All interested parties are invited to submit their views/comments/ documents/evidence (if any) not later than 45 days of the date of publication of this notice in the press in Pakistan. Written submissions provided by interested parties on a confidential basis must be marked "Confidential" and in accordance with Section 31 of the Act, shall be accompanied by a non-confidential version/summary, which will be placed in the public file. Date of preliminary determination:	Not earlier than 60 days and not later than 180 days from the date of initiation of the investigation.
Date of final determination:	Within 180 days of the date of publication of notice of preliminary determination in the press in Pakistan
