#### Notice of Initiation of Investigation for Review of Tariff Structure of Reclaimed Rubber (PCT No, 4003.0000) and its Raw Materials, Tyre Scrap (PCT No. 4004.0020) and Tube Scrap (PCT No. 4004.0090)

National Tariff Commission (the "Commission") received an application on December 20, 2024, under Section 9 of the National Tariff Commission Act, 2015 (the "Act") and Rule 4 of the National Tariff Commission (Procedure) Rules, 2023 (the "Rules") from M/s Anwer Rashid Industries (Pvt.) Ltd. (the "Applicant") for review of tariff structure on Reclaimed Rubber (PCT No, 4003.0000) and its raw materials, Tyre Scrap (PCT No. 4004.0020) and Tube Scrap (PCT No. 4004.0090). The Applicant is a domestic producer of Reclaimed Rubber.

# **Applicant Request:**

The Applicant requested to eliminate import duty on its raw materials (Tyre Scrap, PCT. No. 4004.0020 and Tube Scrap, PCT. No. 4004.0090) only for reclaimed rubber manufacturers. The Applicant also requested for imposition of 100% RD on the export of locally available Butyl Tube Scarp (PCT. No. 4004.0090) and 30% to 40% RD on import of Reclaim Rubber (PCT No. 4003.0000). The Applicant has based its requests on the following:

- i. There is 20% Custom Duties (CD) and 6% Additional Custom Duties (ACD) on its raw materials i.e. Tyre Scrap (PCT. No. 4004.0020) and Tube Scrap (PCT. No. 4004.0090) while 0% CD on its finished product i.e. Reclaimed Rubber (PCT No.4003.0000). This leads to the reverse cascading phenomenon.
- ii. Locally available raw material, Butyl Tube Scrap (PCT. No. 4004.0090) is being exported leaving a shortage for local manufacturers due to 0% Regulatory Duty (RD) on its export.

# **Product under Investigation:**

The products for which this Inquiry is initiated are Reclaimed Rubber (PCT No, 4003.0000) and its raw materials, Tyre Scrap (PCT No. 4004.0020) and Tube Scrap (PCT No. 4004.0090) (the "product under investigation"). Reclaimed Rubber is used in manufacturing of Tyre & Inner Tube Manufacturing, Rubber Products, Footwear etc. while Tyre Scrap and Tube Scrap is mainly used for the manufacturing of Reclaimed Rubber.

# **Initiation of Investigation:**

Upon initial examination of the information and evidence provided in the application, the Commission is satisfied that the application prima facie qualifies for initiation of the investigation under Rule 5(1) of the Rules. Therefore, the Commission has decided to initiate an investigation pursuant to Rule 5(1) of the Rules.
